

MEMORANDUM FOR: SUPPLY PRC MEMBERS

SUBJECT: Approved DLMS Change 60, Revision to DLMS Supplement (DS) 180M,
Material Returns Reporting (Supply)

This change to the DoD 4000.25-M, Defense Logistics Management System (DLMS), reflects an administrative change to the DS 180M, required to support continued logistics operations in the DLSS/DLMS environment. A corresponding change to the Federal IC is required prior to implementation of this revision. The DLMS Supplement will be posted to the DLMSO web site (<http://www.dla.mil/j-6/dlmsso/ICs/Default.htm>) immediately upon coordination/approval of the governing Federal implementation conventions (IC) from the DoD Logistics Functional Working Group (LFWG), the DoD Electronic Data Interchange Standards Management Committee (EDISMC), and the Federal EDI Standards Management Coordinating Committee (FESMCC). Additionally, the revised DS will be provided for implementation planning on the above web site pending Federal approval.

3. REQUESTED CHANGE:

a. Title: Revision to DS 180M, Material Returns Reporting

b. Description of Change: This change modifies the DS 180M to incorporate data elements originally streamlined out of the DLMS. These data elements are reinstated to support conversion to the equivalent DLSS transaction: DI Code FTT, Followup for Inventory Control Point/Integrated Materiel Manager Materiel Receipt Status (Material Returns Program).

c. Procedures: Revise DS 180M, Material Returns Reporting as follows:

d. Alternatives: None identified.

4. REASON FOR CHANGE: This change supports DLMS implementation and desired functionality. The missing segment, data element, and codes were identified during testing of conversion processing. The Followup for the ICP/IMM Materiel Receipt Status contains information originally provided to the ICP/IMM in the Shipment Status Materiel Returns. Some of this data was eliminated from the DLMS under the assumption that it would not need to be retransmitted by the customer, as it would already be resident in the ICP/IMM database. This data is now required for conversion in order to create a complete DLSS transaction.
